



# CORPORATE PROFILE





Nigeria is an acknowledged diverse country in ethno-linguistics, cultural, religious, human and natural resources, gender parity with huge vibrant youths. The country was amalgamated in January 1914 and subsequently obtained her political independent on October 1, 1960. The huge diversity of Nigeria easily created trust-issues between and amongst her huge communities of inhabitants across the country.

Over the years, the advantages that these multi-dimensional diversities should ordinarily have had for Nigeria's development, began to fade-out into challenges with suffocating impact on development and progress of Nigeria and her people. Diversity soon turned into adversity, moving Nigeria into spiral phases of intra and intercommunities' mistrusts, leading to communal clashes over land and resources ownership as well as access to water and other means of livelihood, stigmatizing these disputes and conflicts around identity-related crises. Additionally, national elites continue to manipulate Nigeria's diversity in ethnicity, religion, politics and culture, thereby obstructing opportunities for effective national cohesion and collaboration for Nigeria's development and greatness.

#### The Imperativeness of Justice and Peace

Regrettably, reversing these negative trends, namely fostering national unity, building peace and harmonious co-existence amongst and between communities and promoting faith in Nigeria, have proven to be herculean tasks for successive Governments in Nigeria. The persistence of these challenges have necessitated the urgent need to re-think creative initiatives and platforms that can evolve new network of actors that are committed to enhancement of realizable peace formulae anchored on Justice as sole harbinger of durable peace.

#### A Call for Constructive Change

The challenge before our Network, is to imaginatively construct harmony, equity, and justice by addressing past acts that have inflicted trauma and hindered peace in our communities. We must diligently employ mechanisms based on justice and fairness to resolve conflicts. Addressing issues such as poor governance and the winner-takes-all approach in Nigeria's democracy is vital for harmony and peace in our communities, country, and sub-region.

#### **Leveraging Existing Initiatives**

Our Network aims to build upon the work of the Institute for Peace and Conflict Resolution, whose strategic conflict assessment of Nigeria was last conducted in 2016. This report identifies the threats that face our communities and country and actors as well as potential collaborators and partners, for enhanced engagements, capable of driving peace processes across Nigeria's six geopolitical zones and resource-rich communities in oil, and gas, as well as minerals sectors.

Specifically, this Network shall leverage on the provisions of the PIA (Petroleum Industry Act), to put together a virile network of actors in oil and gas communities as well as Mineral resources areas, for engagements that expand the frontiers of harmonies between and within communities, oil and mineral resources companies, NNPC Ltd and related Governmental regulatory institutions such as the down-stream and up-stream Petroleum Agencies, in order to facilitate Peace in the Industry to enable appropriate benefits be obtained from the oil and gas industries and mineral resources for the development of communities and nation.

Successes in these endeavours will undoubtedly stabilise our oil and gas sectors as well as the mineral resources areas across the country.

#### **Commitment to Peace**

I am privileged and honoured to have received the warm and enthusiastic responses of support and readiness to partner and work with me by Members of the Board of Trustee. Ambassador Abdullahi A. Omaki, nooc, fsma, retired from the Nigerian Foreign Service in June 2013, after thirty-three and a half years of meritorious service. He had a distinguished service career, which took him across Europe (UK and Netherlands), the

USA (Permanent Mission of Nigeria to the UN in New York), and anchoring in Africa (Central Africa Republic, Equatorial Guinea, and Chad), where he served as Head of Chancery in Bangui, Consul-General in Bata and Ambassador Extraordinary and Plenipotentiary in Ndjamena-Chad. He relates easily with issues of the sub-regional security and socio-economic development which he has "consistently argued must be holistically viewed and addressed from the prisms of both bilateral and multilateral instrumentalities. These ways, he believes, would enhance harmony and cohesiveness which are cornerstones for sustainable good governance and peace". Some of his colleagues address him as a "Desert Diplomat" while others politely refer to him as the "Sahel Diplomat", both of which he proudly accepts.

In addition to his overseas tours of duties in the three continents, Ambassador Abdullahi Omaki has diligently served in various Divisions and Departments in the Ministry of Foreign Affairs of Nigeria. These services spanned across Administration, Protocol, West Africa Department, International Organisations, and Inspectorate Departments of the Ministry of Foreign Affairs. He was Deputy Director in the Office of the Minister of Foreign Affairs, Director of the International Organizations Department, and Under-Secretary (Regions and International Originations Directorate).

Upon retirement from service in June 2013, he became the Pioneer Executive Director of the Savannah Centre for Diplomacy, Democracy, and Development (SCDDD) from February 2014 to June 2020. In that capacity, he demonstrated leadership styles that promoted interpersonal skills leading to effective teamwork that contributed to leading the SCDDD to prominence.

In addition to the Mid-level and Senior-level Diplomatic Certificate courses of the Ministry of Foreign Affairs of Nigeria, he holds a BSc degree in Political Science, ABU Zaira, 1979 and an MA Degree in International Relations and Development, of the Institute of Social Studies, 1988, The Hague, The Netherlands.

In June 2020, he was appointed as Senior Special Assistant to the President of Nigeria on Foreign Affairs and International Relations, domiciled in the Office of the Chief of Staff to the President. In



this capacity, he contributed to speeches, statements, analyses of global socio-economic and political events as well as advice and recommendations.

In all of these positions, he garnered experiences that have become an eclectic mix of competencies that have contributed to driving Governance and Organisational priorities in complex situations.

He is the Founder and Executive Vice- Chairman of the ABDULLAHI OMAKI COMMUNITY PEACE INITIATIVES NETWORK (AOCPIN). He is currently, a member of the Body of Neutrals (Mediator) of the Nigeria's Up-stream Petroleum Regulatory Commission's Alternative Disputes Resolution Centre (ADRC).

### Structural Framework of AOCPIN



The current Organizational Framework for AOCPIN's activities, revolves on three layers, namely:-

- 1. The Board of Trustee (BoT): It is both the Policy and Operational clearing house of the AOCPIN, dealing with its Vision, Mission and the Organizational Management, for optimal deliveries of its goals and objectives. The members of the Board of Trustee, are drawn from the six geo-political zones of Nigeria, including representatives from the Central, North and West Africa sub-regions, contiguous to Nigeria and with profound impacts on our country's security, development and progress. The profiles of the members of the Board of Trustee, are captured on pages 08 to 16 of this brochure;
- 2. The National Peace and Harmony Council (NPHC): is the Operational, Advocacy and Engagements Organ, dealing with all the interventions and disputes resolution mechanisms that prioritize PEACE, adopting a whole-of-the-society approach. The members of this Council, are drawn from the Six geo-political zones of Nigeria, and have a broad mandate, governing their activities. The Mandate of the Council and the Profiles of its members, are contained in a separate brochure; and
- 3. The Daily Management Team of AOCPIN (DMT): is the organ that deals with the Daily Management of the activities of the Organization, feeding both the Board of Trustees and the National Peace and Harmony Council as well as serving as the Secretariat for the two Organs. The Daily Management Team is headed by the Executive Director and supported by the Staff of the AOCPIN. The Profiles of the Pioneer Management Team are contained on pages 21 to 24 of this brochure as well as on the website of the Organization, www.aocpin.org.
