ADOPTED MANDATE FOR THE NATIONAL PEACE AND HARMONY COUNCIL

Preamble

The National Peace and Harmony Council (NPHC), is a creation of the <u>Abdullahi Omaki</u> <u>Community Peace Initiatives Network (AOCPIN)</u>. In recognition of the growing need for effective mechanisms to foster, contain, restore, and build peace and harmony within our communities and the nation, this mandate establishes the <u>National Peace and Harmony</u> <u>Council(NPHC)</u>. The decision to establish this is a proactive one by the <u>Abdullahi Omaki</u> <u>Community Peace Initiatives Network (AOCPIN)</u>, dedicated to serving as a dynamic and responsive body of Nigerians, committed to addressing, managing, and preventing crises that threaten the fabric of our society and the general well-being of our people as well as building peace for sustainable national unity and development of Nigeria, as well as the West Africa sub-region and our contiguous neighboring countries. The activities of the NPHC are therefore, expected to reflect the <u>Vision</u> and <u>Mission</u> as well as the <u>Core objectives</u> of its Founding Organization. For ease of the implementation of the activities of the NPHC, AOCPIN shall have four of its **Board of Trustee** members join the Council.

Article 1: Purposes and Scope

1.1 The primary purpose of the AOCPIN's **National Peace and Harmony Council**, is to serve as a **proactive** and **reactive** body to deal with existing and emerging challenges of the different phases of conflicts and crises in our communities across the country and to creatively innovate engagement activities to strengthen concerted advocacies for peaceful coexistence between and amongst all citizens of Nigeria, improve governance to respond to socio-economic matters.

1.2 The Council shall focus on conflict resolution, crisis management, prevention, and fostering a culture of dialogue, understanding, and mutual respect for sustainable community, and national unity in Nigeria and sub-regional harmony.

1.3 The Council shall utilize Mediations and **Alternative Disputes Resolution Mechanism(ADRM)** as well as **Interest-Based Negotiations Mechanism (IBNM)**, embracing the whole-of-the-society approach that could be integrated into the National Security Architecture of the Governments of Nigeria (Federal, State, and Local).



1.4 The scope of the Council's activities shall encompass all the geo-political zones of Nigeria, taking into account the diverse ethno-cultural, religious, and differential developmental stages of Nigeria.

Article 2: Composition and Structure

2.1 The Council shall comprise individuals with deep knowledge and understanding of the socio-cultural and political landscape of Nigeria and commensurate expertise in conflict resolution drawn from the **six geo-political zones** of the country.

2.2 Members shall be appointed based on their proven integrity, commitment to peace, and most importantly, ability to influence desired positive change.

2.3 The Council shall have a **Patron, Chairperson, Vice-Chairperson, Strategy Liaison, and a Spokesperson,** to be nominated by the Founder of the AOCPIN, based on the Vision and Mission of AOCPIN as well as the expected outcomes from the exertions of the Council across the Country and taking into account the vulnerabilities subsisting in the West African sub-region.

2.4 In addition to the above, the Council of the whole shall determine other positions that may be needed to support and facilitate the attainment of the Council's objectives for a better Nigeria

Article 3: Responsibilities and Functions

3.1 The Council shall, in sustained collaborations with the AOCPIN, engage in active monitoring of the national situation, to identify and contribute to the management and containment of emerging threats to Nigeria's safety and survival.

3.2 Develop and implement strategies for conflict management, prevention, and resolution, including mediation and negotiation, between conflicting parties.

3.3 Collaborate with governmental bodies, non-governmental organizations, as well as traditional rulers, community and religious leaders as well as other relevant community influencers to foster dialogue and understanding for national unity.

3.4 Promote education and awareness programs that advocate peace and harmonious cohabitation.

3.5 Provide policy recommendations to assist policymakers in enhancing national unity through sustained management of existing conflicts as well as peacebuilding mechanisms.

3.6 Establish mechanisms for early warning and response to emerging crises, to contain,



mitigate escalation, and facilitate rapid resolution.

3.7 In all its assertions, the Council shall utilize a whole-of-the-society approach for maximum impact on the deliverables, paying significant attention and importance to the roles of the Traditional Rulers, Religious Leaders, and Private Sector Operators as well as the CSOs, the Youth, and Women Organisations.

Article 4: Decision-Making Processes

4.1 Decision-making processes shall be democratic and inclusive, allowing for a diversity of opinions and approaches.

4.2 As much as possible, decisions by the Council shall be by **<u>Consensus</u>** or <u>Simple</u> Majority of those in attendance at the meeting.

4.3. Quorum for meetings shall be by a <u>simple</u> majority of Council Members present at any meeting.

Article 5: Partnerships and Collaborations

5.1 The **Council**, just like the **AOCPIN** shall seek to establish partnerships with local, regional, traditional/interfaith, private sector operators, and international bodies that share similar objectives for a Nigeria desired by her citizens.

5.2 They shall both leverage these collaborations to raise funds, consistent with the laws, and use the same for community capacity building, conflict management, dialogues that seek to foster harmony and peaceful co-habitation, creating awareness, sharing knowledge, and other such activities of the AOCPIN and NPHC, consistent with building a Nigeria, that is desired by her citizens.

Article 6: Accountability, Funding, and Resources Management

6.1 The Council shall operate in a transparent and accountable manner, providing regular reports on the whole gamut of its activities to the Board of Trustees of the AOCPIN.

6.2 The Council shall be funded through a combination of Government(state-actor institutions, critical to peace and stability), Nigeria's private sector operators, and grants by other bodies (National and International) consistent with ethical funding mechanisms.



6.3 All Funds generated shall be domiciled at the AOCPIN's <u>Zenith Bank Account or as</u> <u>may be determined by the Council</u> and be utilized judiciously and efficiently, to ensure maximum impact of the Council's and AOCPIN's activities on national peace efforts.

Article 7: Special Provisions to Operationalise this Mandate

7.1 In order to give effects to Articles **1(1.1 to 1.4)**; **3(3.1-3.7)**, **5(5.1-5.2)**, **and 6(6.1-6.4)**, the Principal Officers of the Council or the Council of the whole, may consider setting-up subcommittees to manage the out-reach to Government(Federal, States, and Loca)I and their Institutions relevant to the objectives and goals of the AOCPIN), International Donor Communities as well as the Private Sector Operators consistent with lawful funding mechanisms that are in the larger interest of a Nigeria that that her citizens desire. Such subcommittees may include but are not limited to the under-listed:-

- I. Steering Committee: This committee will focus on articulations of Strategies and Implementation Templates.
- **II. Fundraising/Outreach Committee:** will seek funding from State and Federal Governments, Stakeholder Institutions, Private Sector Operators, Donor Organizations/Foundations etc.
- **III. Committee for Partnerships and Collaborations:** This committee will Interface with Traditional Rulers and Inter-Faith Organizations, Private-sector operators, Donor organizations/Foundations (National and International)Women, Youths, and the vulnerable as well as Stakeholder Institutions for Peace, Stability, and Development (at Federal, State, and Local levels)
- **IV. Strategy and Communication Committee:** This committee focuses on the strategies for communicating the vision and mission of the AOCPIN

7.2 The AOCPIN **Programs Officer** will work with the **Steering Committee** to articulate and generate proposals to facilitate the Council's advocacy engagements across communities and arms of Governments(Federal and State). Such proposals necessarily may come with funding opportunities.

Article 8: Frequency and Forms of Meetings

8.1 The AOCPIN may convene Strategic Sessions on a quarterly basis or as issues may arise to evaluate and refocus with a view to attaining set objectives and goals.



8.2 In the event that NPHC is engaged in any project/activity, it shall be absolutely necessary that a weekly/bi-weekly evaluation is embarked upon to provide timely updates on the overall project objectives.

8.3 Meetings shall be both physical and virtual

8.4 AOCPIN shall occasionally propose an honorarium as may be appropriate in appreciation of the participation and contributions of the Council members in any of the projects or activities of the Organization, subject to the availability of funds.

8.5 However, the Organization shall bear the cost of traveling by air or road while other related expenses shall be as per the tentative template below:-

Article 9: Council Secretariat

9.1 The Secretariat of the Council shall be Headed by the Executive Director of the AOCPIN and assisted by **Amb. M.A. Atose**, **Dr. Abdulrahman Hamisu**, **Prof. Musa Ogah** and the Program Officer of the AOCPIN.

9.2 The Secretariat will craft action plans with strategic implementation mechanisms for the Council's considerations and decisions.

9.3 The Secretariat shall prioritize the low-hanging fruits as promotional activities that draw attention to AOCPIN and the Council.

9.4 The Secretariat shall be responsible for taking minutes and submitting reports to the Council.

Article 10: Amendments

10.1 This mandate may be amended as necessary to reflect the evolving context of the work of the Council and the needs of the nation, in its pursuit of peace, harmony for growth and development.

1.0 STRATEGY AND STRATEGIC COMMUNICATION PLAN FOR NPHC

1.1 Introduction

The setting up of the AOCPIN, as a Non-Governmental Organization, with a commitment to establishing an Advocacy Dialogues Council called the **National Peace and Harmony Council (NPHC)**, is very timely. The Council is a Strategic Policy Group, comprising professionals and experts dedicated to fostering unity through sustained collaboration, addressing social cohesion, and contributing to national well-being through advocacy and dialogue.

The Council focuses on conflict resolution, crisis management, crisis prevention, and fostering a culture of dialogue, understanding and mutual respect for sustainable for sustainable community for National unity in Nigeria sub-regional harmony. It also has three objectives namely (a) Proactively and Reactively. managing conflicts and crises (b) Strengthening advocacy for peaceful coexistence and (c) improving governance responses to socio-economic issues. To achieve its objectives, NHPC hopes to maintain effective partnerships with critical state actors who are determined to achieve national peace and harmony in Nigeria.

Among the Committees set up for the execution of the tasks of the NPHC is the **Strategy and Communication Committee.** In line with the scope of the NPHC Activities, including forging effective links with numerous stakeholders outlined in the Adopted Mandate for the National Peace and Harmony Council Released On 5th June 2024 (**Pages 01-05**) with specific reference to stakeholders' engagement in **Articles 1**, **3**, **6 and 7**, there is need for the development of a strategic plan as well as Communication strategy which will cover all the geopolitical zones of Nigeria, taking into account Nigeria's diverse ethnocultural, religious, and differential developmental stages.

1.2 Developing a Strategy for NPHC

Considering the objectives of the NPHC the need for a strategy towards achieving those is indubitable. Our committee suggests adopting an **Issue-based strategy** which provides us with a comprehensive strategic plan that will ensure NPHC remains focused, proactive, and effective in achieving its mission and goals amidst changing circumstances. Based on this, pages 08-11 captures 18 broad Strategic **Issue-Based Plan (SIBP)**, with strategies to address them and the mode of implementation for each.

3.0 COMMUNICATION STRATEGY FOR NPHC

Aligning with AOCPIN's Mandate of promoting peace, preventing crises, and fostering unity in Nigeria, (Pages 01-05 and 08-11) the National Peace and Harmony Council (NPHC) requires a strategic communication plan.

3.1 Proposed Communication Strategy for NPHC

To realize its objectives and maximally deliver on the set-out strategies in 2.0 above, the SCC has developed a communication strategy that is in sync with its Terms of Reference which includes:

- (a) identifying relevant stakeholders
- (b) effectively communicating with the stakeholders
- (c) identifying target audiences, delivering targeted messages timeously, and selecting communication channels across diverse media channels.

3.2 Justification for Strategic Communication Plan (SCP)

The importance of Strategic Communication as reckoned by the Strategy and communication committee of the NPHC is to support the implementation of the objectives of the NPHC and facilitate the effective implementation of the Strategic –Issue-based - plan (SIPB) at 2.0 above. Accordingly, the SCP is essential for the reasons stated below:

- (a) Enhancing the awareness of the government and other relevant stakeholders by disseminating information about NPHC's activities and initiatives and fostering support for the Council's peace-building and other efforts. This will be achieved by providing regular updates through social media, press releases, and community engagement activities.
- **(b)** Building Stakeholder Trust through transparent and consistent communication is vital for building trust among stakeholders, including government agencies, NGOs, and local communities. For example, transparent reporting on the progress and impact of the NPHC programs will be essential.
- (c) Facilitating Dialogue and Engagement through dialogue and active participation from diverse groups, fostering mutual understanding and collaboration. Targeted programs and activities will be required including organizing forums, webinars, and workshops to engage stakeholders.
- (d) Crisis Management is to be carried out by providing a framework for effective communication and ensuring timely and accurate information dissemination to mitigate conflicts. This will require the SCC to develop communication protocols, identify, and train its spokespersons, and facilitate their effectiveness.
- (e) Promoting NPHC Policy Advocacy efforts by articulating clear and compelling messages to policymakers and influencing Government and other stakeholders



opinions, producing policy briefs, and engaging in media campaigns to highlight the importance of peace-building policies.

Conclusion A strategic communication plan is indispensable for the National Peace and Harmony Council (NPHC) to achieve the mandate of AOCPIN and effectively execute its objectives. The SCP will equally ensure that communication efforts are aligned with strategic goals, enhance stakeholder engagement, and support the overarching mission of fostering peace and harmony in Nigeria. For this, the SCC has identified a broad spectrum of stakeholders listed below, which may be segmented further into specific groups for messaging and effective reach.

Ambassador Zubairu Dada (CON, FNIM, FNIPR) is a distinguished Nigerian diplomat with over four decades of experience in Public Service and Diplomacy. He holds a B.A. in English/French and a Graduate Certification in

Education from Ahmadu Bello University, Zaria, as well as an M.A. in Law and Diplomacy from the University of Jos.

Ambassador Dada's career is marked by significant contributions at both National and International levels. He began his professional journey with the National Youth Service Corps in Lagos State and later served as the Pioneer Hansard Editor for the Niger State Legislature. His roles included Information Officer in Sokoto, Permanent Secretary, Director of MAMSER, and Director of the National Orientation Agency.

Ambassador Dada has represented Nigeria on the global stage as Ambassador to the Republic of Poland (1999-2003) and High Commissioner to the Republic of Mozambique, with concurrent accreditation to Madagascar and Mauritius (2004-2007). He also served as the Federal Commissioner at the Revenue Mobilization, Allocation, and Fiscal Commission in Abuja (2011-2016) and was appointed **Minister of State for Foreign Affairs (2019-2023)**.

In addition to his professional roles, Ambassador Dada has held numerous positions, including Chairman of the Niger State Merit Award Committee and Member of the Economic and Social Advisory Council of Niger State. His exemplary service has been recognized with several awards, including a National Honour as Commander of the Order of the Niger (CON).

Ambassador Dada is also a Fellow of the Nigerian Institute of Management (FNIM) and the Nigerian Institute of Public Relations (FNIPR). He holds the traditional title of Makun Paiko. He is Married with children, he enjoys football, walking, lawn tennis, and golf.





Col. (Rtd) Lawan Gwadabe

Col. Lawan Gwadabe- Military Historian and Strategist. He holds a Bachelor of Arts Degree in Military History and two Masters of Arts Degrees in International Relations and History respectively from the Oklahoma State University, in the United States.

Col. Lawan Gwadabe has an impressive Military career, graduating from the prestigious Nigerian Defence Academy with a Regular Combatant Commission in the rank of Second Lieutenant on September 9th 1972 with Seniority in the same rank with effect from April 16t, 1970. He rose to the substantive rank of a Colonel in 1991.

Col. Gwadabe has attended many professional courses, including the Command and Staff College, Jaji. He served in various strategic Military postings, which include: Battalion Training Officer; Battalion Adjutant; ADC to Commander Lagos Garrison Organization; Assistant Deputy Military Secretary (AHQ-MS) Adjutant, Nigerian Defence Academy; Colonel GS Directorate of Armour and Colonel GS Lagos Garrison Command.

Colonel Gwadabe was Managing Director, Nigerian National Shipping Lines and thereafter held a distinguished tenure as Military Governor of Niger State from 1987-1991. In the wake of his positing he was appointed the Commander of the Nigerian National Guard. Other postings include: Principal Staff Officer to the Head of State and Commander-in-Chief of the Armed Forces. He was posted as the Chief of Army Staff of the Gambian National Army. His last posting before retirement was Commander, 23 Armoured Brigade Yola. Gwadabe was also appointed the Chairman of the Federal Road Safety Corps in 2009.

Col. Gwadabe as the PSO to the Head of State and C-in-C, was the most towering influential and charismatic figure in the Villa. He was unquestionably, the Administration's ideas man, setting the pace as well as it's agenda. Lawan Gwadabe a committed patriot, visionaire and philanthropist has had fundamental assignment in conflict resolutions as Nigerian Special Envoy to the troubled African States of Angola, Mozambique and was indeed for four years1986-1991, Chairman of the Sudan Peace Process which provided the blue print for the Abuja Accord that formed the framework for the eventual resolution of the conflict resulting in the two countries settlement.






Major Gen. (Rtd) S.U. Labaran MEMBER



Rev. Fr George O. Ehusani


